### 1. **IDENTIFICATION OF THE PRODUCT AND THE COMPANY:**

### 2. **COMPOSITION / INFORMATION ON CONSTITUENTS (COMPONENTS):**

*Chemical nature of the product:*

FRAGRANT AQUEOUS SOLUTION CONTAINING PHOSPHORIC ACID

*Component relevant to the risk factor:*

**PHOSPHORIC ACID**

### 3. **IDENTIFICATION OF THE RISKS:**

This descaling agent is not a dangerous product however, given the presence of PHOSPHORIC ACID diluted in the product, this can have an irritating action for the skin and the eye mucous membranes. The risk of irritation to respiratory tracts is small.

---

### 4. **FIRST AID:**

*Contact with eyes:* wash thoroughly with clear water or salty water for 15minutes. If the irritation persists, consult doctor.

*Contact with the skin:* remove contaminated clothes and wash affected parts abundantly with water.

*Ingestion:* Call an emergency doctor and show him (her) the label of the product. Do not induce vomiting.

### 5. **MEASURES AGAINST FIRE:**

*Particular risks of fire or explosion:* incombustible and non-explosive product. When heated, risk of emission of acid smoke (oxide of phosphor).

*Means of extinguishing:* powder, foam, carbon dioxide.

6. **MEASURES TO TAKE IN CASE OF ACCIDENTAL SPILLAGE:**

Avoid discharge of the product into the sewage system or into streams or rivers. Collect the spilled liquid in a container, otherwise absorb it with some sand. Consult a specialist about the disposal of the product.

7. **HANDLING AND STOCKING:**

*Precautions for handling:* Avoid contact with the skin and eyes.

*Precautions for storage:* stock in well ventilated locations, on a waterproof surface, protected from light and from heat, and not on any metal surface.

*Materials of packaging or bottling:* polyethylene. 5 litre containers.

*Special health and safety precaution:* *Eyewash stations to be sighted near storage areas.*

8. **RECOMMENDED PPE**

The wearing of gloves and safety glasses is recommended during the handling of the product.

10. **STABILITY AND ABILITY TO REACT:**

*Dangerous reactions with:* lime, nitrates, chlorates.

*Corrosive properties/reaction with other materials:* formation of hydrogen in the presence of numerous metals.

*Ingestion:* can cause burns, sickness, vomiting and diarrhoea.

*Contact with the skin:* can cause a temporary local irritation of the skin.

Neutralization of the product in pH 7 +/-1,5 before any discharge in the sewage system.

**13. DISPOSAL OF THE PRODUCT:**

Do not dispose of the product into drains, sewerage system, streams or rivers. Neutralize the product with an alkaline carbonate, then wash abundantly in water.
