2. Entry is only open to NEW SOUTH WALES (NSW), QUEENSLAND (QLD) SOUTH AUSTRALIAN (SA) WESTERN AUSTRALIAN (WA) NORTHERN TERRITORY (NT), VICTORIA (VIC), TASMANIA (TAS) residents who are licensed plumbing contractors or are an account customer of participating Samios branches that display promotional advertising featuring this promotion ("Eligible Entrant"). Local State and Federal Government departments, institutions and cash sale customers are excluded. Employees (and their immediate families) of the Promoter, participating Samios branches and agencies associated with this promotion are also ineligible to enter.

22. The PROMOTER reserves the right, at any time, to validate and check the authenticity of entries and entrant's details (including an entrant's identity, age and place of residence). In the event that a winner cannot provide suitable proof as required by the PROMOTER to validate their entry, the winner will forfeit the prize in whole and no substitute will be offered.
